Section 1. Purpose.

The City Council adopts this Ordinance to require the posting of human trafficking hotline posters at various establishments within the City of Jackson.

<u>Section 2</u>. That Chapter 16 be amended to amend Section 15-25 to the Code of Ordinances of the City of Jackson, and the same hereby is, amended to read as follows:

Every sexually oriented business; any establishment that receives a liquor license; bus station; hospital; urgent care center; high school; and job recruitment center shall post in a conspicuous place near the entrance of the business or where such posters and notices are customarily posted, the poster required by the Human Trafficking Notification Act, MCL 752.1031 et seq. A copy of the poster may be downloaded from the City of Jackson website.

Section 3. This Ordinance takes effect thirty (30) days from the date of adoption.

# HUMAN TRAFFICKING NOTIFICATION ACT (EXCERPT) Act 62 of 2016

752.1033 Posting of human trafficking notice on certain premises.

Sec. 3. (1) The department of transportation shall post a human trafficking notice on the premises of each rest stop and welcome facility in this state in the manner described in this act and as required by the department under this act.

(2) Each local unit of government that operates a rest stop or welcome facility shall post a human trafficking notice on the premises of that rest stop or welcome facility in the manner described in this act and

as required by the department under this act.

(3) Each local unit of government, or authority allowed by law, that provides bus or rail transportation services to the public shall post a human trafficking notice on the premises of any station that provides those services in the manner described in this act and as required by the department under this act.

(4) Each of the following shall post a human trafficking notice on its premises in the manner described in

this act and as required by the department under this act:

- (a) Any entity that owns property that has been found by a court to constitute a public nuisance due to acts of prostitution or human trafficking being conducted on the property or arising out of the ownership or use of the property.
  - (b) An adult entertainment establishment.
  - (c) Public airports.

Posting required by Public Act 62 of 2016 - Human Trafficking Notification Act

# Recognize the potential red flags and signs of human trafficking:

# **Common Work and Living Conditions:**

- He or she is in the commercial sex industry and has a pimp/manager.
- He or she is unpaid, paid very little, or paid only through tips.
- He or she owes a large debt and is unable to pay it off.
- He or she was recruited through false promises concerning the nature and conditions of his/her work.

## **Poor Mental Health or Abnormal Behavior:**

- He or she is fearful, anxious, depressed, submissive, tense, or nervous/paranoid.
- He or she exhibits unusually fearful or anxious behavior when law enforcement is discussed.

### **Poor Physical Health:**

- He or she appears malnourished or shows signs of repeated exposure to harmful chemicals.
- He or she shows signs of physical and/or sexual abuse, physical restraint, confinement, or torture.

#### **Lack of Control:**

- He or she has few or no personal possessions.
- He or she is not in control of his/her own money, has no financial records or bank accounts.
- He or she is not in control of his/her own identification documents (ID or passport).
