Skate Park Rules and Regulations

- SKATEBOARDING/ROLLERBLADING AT YOUR AT YOUR OWN RISK
- Skateboards and in line skates only
- Participants must follow all directions given by Nixon Park Staff.
- Each skater must pay the daily rate or have obtained a skate facility permit before entering the skating area.
- Each skater must be cleared by the skate facility office prior to entering the skate area
- Loitering and/or trespassing not permitted
- Bicycles not permitted inside facility
- Tobacco, drugs and alcohol not permitted in the park
- Profanity will not be tolerated
- Helmets are required for everyone. Safety Equipment is highly recommended for all. However if you are 12 or under you must wear wrist, knee and elbow pads along with the helmet.
- The park is not responsible for any broken, stolen or damaged boards, blades or personal property.
- Food/beverage allowed only in designated areas
- No glass containers
- Skateboards/in line skates may be used in authorized area only
- Dangerous behavior is not allowed. Please respect others and the Nixon Park Facility.
- Management reserves the right to schedule organized activities at anytime without notice
- Equipment and facilities will be used in accordance with posted regulations
- Litter, Graffiti and Vandalism is not allowed.

Wavier of Liability

The undersigned acknowledges that he/she agrees to participate and/or utilize, at his/her own risk, the City of Jackson Nixon Park skateboard facilities located at 400 East North Street, Jackson, Michigan (hereinafter "Nixon Park"), and hereby agrees to indemnify, defend, and save the City of Jackson and its agents, officers, representatives, and employees (hereinafter "City"), harmless from and against any and all liability, costs or losses, resulting from any and all claims, demands, suits, actions, payments or judgements including any and all expenses, legal or otherwise, incurred by the City, in the defense of any claim or suit, arising from personal injuries, property damage, bodily injury, death, or otherwise, brought or recovered against the City, arising directly or indirectly by reason of any act or omission of the undersigned, the City, or any guest or participants at Nixon Park. I give permission for medical treatment to be given if necessary and I agree to be responsible for all costs associated with said medical treatment.

I also agree to wear a helmet, and if you are 12 or under, I acknowledge I must wear knee, wrist and elbow pads when using the skate park. I agree to obey the rules and requirements of the skate park. I understand that I will be prohibited from using the Nixon Park facilities if I do not follow the rules and regulations.

DISCIPLINE POLICY: On the first offense you will receive a warning, on the second you will be asked to sit out for 15 minutes and on the third offense you will be removed from the park.
